Pomfret's Comments to TRORC hearing on 1/22/25:

The Pomfret Planning Commission has been in the process of updating the Pomfret Town Plan. In this process we had a hearing in April of 2023 where many landowners, Planning Commission members, Selectboard members and TRORC staff were present. The conclusion was that the TRORC Regional Draft Plan's Future Land Use Map, the Natural Resources Map that includes-Interior Forest Blocks and Connectivity Blocks along with the Goals Policy and Recommendations in Chapter 3, Land use, are not appropriate for Pomfret. Given the vast amount of forestland in Pomfret, there is no valid justification for designating forest blocks and corridors within certain landowners' properties and not others.

The process that should have been followed:

24 4302 (2) To encourage citizen participation at all levels of the planning process and to assure that decisions **shall** be made at the most local level possible commensurate with their impact.

Title 24VSA 117, chapter 4348... At the outset of the planning process and throughout the process, regional planning commissions shall solicit the participation of local citizens and organizations by holding informal working sessions that suit the needs of local people.

Pomfret Planning Commission would like to go on record that this above process was not followed, and we were not involved in any of the process leading up to the Maps and Goals Policy and recommendations in the Land use section Chapter 3 that were adopted in 2020. It is our request that the TRORC Regional plan will have no authority on Pomfret lands as it pertains to the Maps, Goals, Policy and Recommendations mentioned above.

Pomfret's 25,280 acre landmass includes: 25,280 acres are predominately forested 18,707 acres are in current use

6,400 acres are permanently conserved 12,640 acres have steep slopes greater than 25%

Landowners: see attached.

We feel that Pomfret landowners have a long history of stewarding the land well by fostering agriculture, forestry, and integrated, home-based businesses and conditional uses. We also have local zoning regulations in place that have done an amazing job of supporting and maintaining these land uses. We don't require any future top down regulation that the above mentioned steep slopes, existing forestland, and conservation are not already providing.
